Requirements to be a recreation mentor include:

- 1. Must have used the Fort Cavazos iSportsman system and participated in the activity you want to mentor in the past year
- 2. Must have a valid Fort Cavazos access pass obtained by visiting the Marvin Leath Visitor Center REGARDLESS of whether you already have access via another means (e.g. CAC card, retiree card)
- 3. Must be familiar with navigating the Fort Cavazos landscape for the activity you wish to mentor
- 4. Must be familiar with and obey all current Texas game laws as well as Fort Cavazos regulations (FC CIR 210-22, FC REG 210-25, and the Fort Cavazos Hunting, Fishing, and Natural Resources Use Guide)
- 5. Must be 18, have a valid Driver's License, and have the ability to drive a motor vehicle on Fort Cavazos.

 Note: Hunting mentors must have completed a Hunter Safety course
- 6. Must submit a Fort Cavazos Recreation Mentor Application
- 7. Must attend an orientation provided by DPW Natural Resources Branch personnel
