Hunting and Fishing Bag Limits and Seasons

1. HISTORY. This revision is an administrative revision. Portions affected by this revision are listed in the summary of change.
2. SUMMARY. This Circular (CIR) sets hunting and fishing bag limits and seasons at Fort Cavazos.
3. APPLICABILITY. This Circular (CIR) applies to anyone hunting, fishing, or participating in general recreation activities at Fort Cavazos.
4. SUPPLEMENTATION. Local supplementation of this regulation is prohibited without prior approval of the Directorate of Public Works (DPW).
5. SUGGESTED IMPROVEMENTS. The proponent of this Circular is the DPW. Users are invited to send comments and suggested improvements to the Commander, III Armored Corps and Fort Cavazos, ATTN: IMHD-PWE, Fort Cavazos, Texas 76544-5000.

1. OVERVIEW.

a. Purpose:

This circular establishes hunting controls, fishing limitations, special lake restrictions, and bag limits and seasons at Fort Cavazos.

2. HUNTING.

a. Hunting controls:

This section outlines controls on weapons, seasons, hours of shooting, and possession limits at Fort Cavazos. Allowances do not exceed those established by the Texas Parks and Wildlife Department (TPWD).

b. Game Limitations:

(1) Mourning Dove, White Wing Dove, White-Tipped Dove

Season	1-Sep-2024 – 27-Oct-2024 and 13-Dec-2024 – 14-Jan-2025 One-half hour before sunrise to sunset. Subject to change per federal mandates.
Bag Limit	15 per day, not more than 2 white-tipped dove in the aggregate.
Possession Limit	45
Means & Methods	Shotgun not larger than 10- gauge with BB-size shot or smaller, plugged with a one-piece filler to a three-shell capacity, including one in the chamber; smooth bore (shot) muzzleloaders with BB-size shot or smaller; legal archery equipment.
Licensing Endorsements	Migratory Game Bird

(2) Early Teal

Season	14-29-Sep-2024
Bag Limit	6 per day
Possession Limit	18

Means & Methods	Shotgun not larger than 10- gauge with BB-size shot or smaller, plugged with a one-piece filler to a three-shell capacity, including one in the chamber; smooth bore (shot) muzzleloaders with BB-size shot or smaller; legal archery equipment; approved non-toxic shot only (shot) muzzleloaders with BB-size shot or smaller; legal archery equipment; approved non-toxic shot only
Licensing Endorsements	TPWD Migratory Game Bird Federal Duck Stamp

(3) Duck or Goose

Season	Per state and federal regulations.
Bag Limit	Per state and federal regulations.
Possession Limit	Per state and federal regulations.
Means & Methods	Shotgun not larger than 10- gauge with BB-size shot or smaller, plugged with a one-piece filler to a three-shell capacity, including one in the chamber; smooth bore (shot) muzzleloaders with BB-size shot or smaller; legal archery equipment; approved non-toxic shot only
Licensing Endorsement	TPWD Migratory Game Bird Federal Duck Stamp

(4) Bobwhite Quail

Season	26-Oct-2024 – 23-Feb-2025
Bag Limit	5 per day
Possession Limit	15
Means & Methods	Shotgun not larger than 10- gauge with BB-size shot or smaller; smooth bore (shot) muzzleloaders with BB-size shot or smaller; legal archery equipment.
Licensing Endorsement	Upland Game Bird

(5) Turkey

a. Spring Turkey Season

Season	Spring: 29-Mar-2025 – 11-May-2025. Special youth season: 22&23-Mar-2025 and 17&18-May-2025. One-half hour before sunrise to one-half hour after sunset. .
Bag Limit	3 tom (male) turkey. Limit 1 per hunt. Limit 3 turkeys per license year (see Fall Season below).

Possession Limit	Same as bag limit.
Means & Methods	Shotgun not larger than 10- gauge with BB-size shot or smaller; smooth bore (shot) muzzleloaders with BB-size shot or smaller; legal archery equipment.
Licensing Endorsement	Upland Game Bird

b. Fall Turkey Season

Season	Fall: 2-Nov-2024 – 5-Jan-2025. Archery Only season: 28-Sep-2024 – 1-Nov-2024. Youth Only season: 25,26,27-Oct-2024 and 6-Jan-2025 – 19-Jan-2025. One-half hour before sunrise to one-half hour after sunset
Bag Limit	3 bearded turkey. Limit 1 per hunt. Limit 3 turkeys per license year (see Spring Season above).
Possession Limit	Same as bag limit.
Means & Methods	Archery Only season: legal archery equipment only Deer option: Shotgun using slug load; muzzleloader; legal archery equipment. Turkey option: Shotgun not larger than 10- gauge with BB-size shot or smaller; smooth bore (shot) muzzleloaders with BB-size shot or smaller; legal archery equipment.
Licensing Endorsement	Upland Game Bird Archery (required during Archery Only Season)

(6) White-Tailed Deer

Season	General season: 2-Nov-2024 – 5-Jan-2025. Archery Only season: 28-Sep-2024 – 1-Nov-2024. Youth Only season: 25,26,27-Oct-2024 and 6-Jan-2025 – 19-Jan-2025. Special Late (antlerless and unbranched antler) season: 6-Jan-2025 – 19-Jan-2025. One-half hour before sunrise to one-half hour after sunset.
Bag Limit	3 white-tailed deer - not more than: 1 antlerless, 1 buck with unbranched antler, and 1 branch antlered buck with inside spread 13 inches ¹ or greater.
Possession Limit	Same as bag limit.
Means and Methods	Archery Only season: legal archery equipment only

	Shotgun using slug load; muzzleloader; legal archery equipment.
Licensing Endorsement	Archery (required during Archery Only Season)

(7) Furbearing Animals

Season	Trapping season: Per state regulation.
Bag Limit	Per state regulation.
Possession Limit	Per state regulation.
Means and Methods	Shotgun not larger than 10- gauge with BB-size shot or smaller; smooth bore (shot) muzzleloaders with BB-size shot or smaller; legal archery equipment.

(8) Squirrel or Rabbit

Season	No closed season.
Bag Limit	10 per day.
Possession Limit	20
Means and Methods	Shotgun not larger than 10- gauge with BB-size shot or smaller; smooth bore (shot) muzzleloaders with BB-size shot or smaller; legal archery equipment; legal air rifle per state regulations that is at least .177 caliber but not greater than .25 caliber.

(9) Unprotected Wildlife

Season	No closed season.
Bag Limit	No limit.
Possession Limit	No limit.
Means and Methods	Shotgun not larger than 10- gauge with BB-size shot or smaller; smooth bore (shot) muzzleloaders with BB-size shot or smaller; legal archery equipment.

(10) Wild Pig

Season	No closed season.
Bag Limit	No limit.
Possession Limit	No limit.

Means and Methods	Pig hunting option: Shotgun using slug load or buckshot; muzzleloader; legal archery equipment. Deer hunting option: Shotgun using slug load; muzzleloader; legal archery equipment. <i>(Deer and Pig hunting options only available (~Oct-Jan))</i> Small/Non-Game & Turkey hunting options: Shotgun not larger than 10- gauge with BB-size shot or smaller; smooth bore (shot) muzzleloaders with BB-size shot or smaller; legal archery equipment.

3. FISHING.

a. Fishing Controls:

Section 3.2 shows possession limits that apply on Fort Cavazos.

(1) Allowances do not exceed those established by the Texas Parks and Wildlife Department (TPWD).

(2) Other species conform to Texas state law.

b. Fishing limitations:

Table 3-1 shows limitations lakes and ponds on Fort Cavazos.

c. Special lake restrictions:

Table 3-2 shows lakes and ponds on Fort Cavazos with special restrictions.

Table 3-2. Restrictions

Lake	Restriction
Cantonment B (Kid's pond)	Boats or flotation devices are prohibited at all times. Pond is designated as kids-only fishing. All adults must be accompanied by at least one (1) fishing child 16 years old or younger.
East Lake	Catch and release only. No fish from this pond may be kept for consumption. All fish must be released. This pond is a permitted facility.
Birdbath Lake	Catch and release only. No fish from this pond may be kept for consumption. All fish must be released. This pond is a permitted facility.
Landfill Lake	Per III Armored Corp Garrison Safety, fishing is not permitted in Landfill Lake.
Gray & Bratcher Lakes	Per Directorate of Aviation Operations, fishing is not permitted at Gray or Bratcher lakes.

Plastic Lined Ponds	Fishing is not permitted in the plastic lined ponds.
